## In The Know

**Talking with:** Christina Cain

**Employed by law firm:** The Wright Firm, LLP (since Oct 2010)

**Years' experience:** Six years

**What made you want to become a paralegal?** I became a paralegal with the hope that I could help others going through this miserable life experience after going through my own highly contested divorce with child custody. I became a paralegal in the most untraditional way. After my own divorce concluded I was hired by the attorney who handled my divorce. Unbeknownst to me, I was on the longest job interview I didn't know I was on.

**What type of law did your attorney practice?** The first attorney I worked for only practiced family law.

**What was it like being a new paralegal?** Very interesting. I quickly learned that "real life" is definitely more dramatic than any soap opera. Some days were frustrating and challenging since I was so "green" and didn't have any formal training to fall back on, but overall it was rewarding knowing that I was able to take the knowledge gained from my personal experience and use it to help people. I am grateful that my attorney/mentor was a patient man who took the time to train me well and teach the importance of good and thorough drafting. Through my personal experience, I feel I have a level of empathy and understanding for clients in some of the most difficult situations.

**How many paralegals are at your current firm?** The Wright Firm, LLP employs five family law paralegals and a total of seven paralegals are with the firm. Some of the family law paralegals also work with the other attorneys in another discipline of law.

**What kind of law is practiced at your current firm?** The Wright Firm, LLP has attorneys that practice in the following areas: Family Law; Criminal Law; Bankruptcy; Wills, Probate and Estate Planning; Taxation; Civil Law; Business Organization; Immigration; and Personal Injury.

**What is your advice to new paralegals?** The biggest piece of advice I would share is that the calendar is the most important thing to maintain. It is a paralegal's responsibility to remind their attorneys of the upcoming deadlines. Your attorneys rely on you to keep them informed of the next three steps, especially since they are often out of the office or away from their desks for court appearances, mediations, depositions and new client meetings. Also, I would tell new paralegals that it is important to find a mentor. Lastly, I would pass on some words of wisdom that I received, "Don't do things to get a reputation of being difficult". This means don't get so caught up in the case that you forget that you will continue to work with opposing counsel and their staff, court coordinators, and court clerks on other cases in the future.

**To which paralegal organizations do you belong?** DCPA

**How do you relax after a tough day at work?** I go home to my daughter and enjoy being her mom. The tough days remind me that I fought hard to have that right and privilege and remind me that I am trying to help other parents do the same. Being a part of the "craziness" that is family law, makes me realize how important and precious the time away from the office is to maintain a healthy balance.
