It looks as though the local legal economy has taken a step towards recovery judging from the amount of firms hiring additional staff. That's great news! Most of us are happy where we are, but for those of us who are ready for a new challenge, its time to plan and prepare for a successful job search. Here are a few tips we thought worth mentioning, based on our recent round of hiring for both paralegals and legal secretaries.

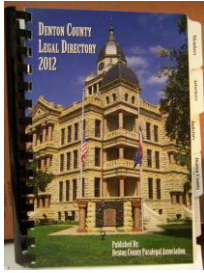
Update your resume: read professional articles on how to brush up your old one or seek out a reputable company to help you. Tailor it to the position you are seeking and keep it brief. Include skills and experience from non-legal endeavors if they would be useful in the new position or show important professional depth. Don't list every single task you ever performed, stick with your main areas of responsibility. Try not to guild the lily too much with fancy terms for duties performed, the reviewer will know that is what you did and think that you are insecure about what you can offer. Include dates, don't be vague!

The all important cover letter: This is the real door to landing the interview for me. Whether the posting requires it or not, provide one. Of course, make sure it is well written, concise without being curt, tailored to the company and addressed to the correct person in the firm and engaging. Miss the mark with your cover letter and it's likely you won't be called for an interview. You can show a little personality here, just not too much! Proofread!

The interview: Be punctual! Your clothing, hair and makeup will be professional but it should also be fresh and polished. You want to look approachable, smart, and confident. Your resume speaks to your abilities and got you the interview. The interview should tell the rest of the story. Before the interview look over the company/firms website again. You already did that once before you sent the resume, right? They *expect* you to have perused it, so be prepared to make mention of something from it to the interviewer. He or she will be gratified that you took an interest and you will look like an energetic, research oriented, can-do candidate! Don't forget, the interview is a two-way street. Is this the right place for you? Ask questions, be honest and be upbeat. After the interview, be careful how much follow up you do. Too little, you don't really care, too much and you are annoying! Needs to be just right!

The TBLs examination is November 9, 2013, in Austin, Texas. The specialty areas of law available for certification are: Bankruptcy, Civil Trial Law, Criminal Law, Estate Planning and Probate, Family Law, Personal Injury Trial Law and Real Estate Law. I highly encourage you to explore the possibility of becoming one of the state's elite paralegals by becoming board certified. For more information visit: <http://www.tbls.org/Cert/Paralegal.aspx> or call 855.277.TBLS(8257). To help with this, DCPA has allotted a scholarship of \$250.00. The Application and instructions can be found <http://www.dentonparalegals.org/resources.html>. Please submit your application to the Scholarship committee by August 30th so that they have to be forwarded to the Executive Committee no later than September 15th to be announced at the October meeting.
