 6. Membership Chair, Gina Elliott, reported that the membership applications for 2013 have been sent out with a CLE survey with all members encouraged to send their applications back as soon as possible so dues can be collected; and for all members to send an application to anyone who might be interested in becoming a member so we can grow our numbers.
 7. President Sherman made the following announcements:
