# Time to Renew Your Membership!

February 1st marks the renewal date for most members' membership. Members can renew their membership on the association website. Payment can be made by credit or debit card or PayPal securely on the website or by mailing a check.

Please follow the steps below to renew your membership today. If you see that your renewal date after renewing would be later than February 2016, please stop the renewal process and contact membership committee chair Sunnie Palmer.

Step 1: Go to [www.dentonparalegals.org](http://www.dentonparalegals.org) and click "Log In" in the upper right corner.

Step 2- part a: Log in using your email address and password.

Step 2- part b: If you have never logged in before or if you have forgotten your password, click the "Forgot Password" Link, and you will be prompted to choose a new password.

Step 3: When you have logged in, you will see a black bar across the top of the screen with your name, "Change Password", and "Log Out". Click the second blue tab, "Apply".

Step 4: On the bottom of the page, you will see a warning "You are already a member." Click on the link "Edit your member profile."

Step 5: Click on "Renew until February 1, 2016". The date you see may be slightly different. If the date you see is after March 2016, please email [sunnie@zellmerlaw.com](mailto:sunnie@zellmerlaw.com) before renewing.

Step 6: Review your member profile for any changes, and then click "Update and next".

Step 7: Review and confirm your information and click "Confirm".

Step 8: If you choose to pay online with credit card or PayPal, click "Pay online". If you choose to pay by mailing a check, click on the blue Invoice link.

Step 9- paying online: If you have selected to pay online, you will see the screen below. You can either log in to your PayPal account to pay, or Click "Pay with a debit or credit card" to pay directly with a credit or debit card. If you do not have a PayPal account but would like one, in another tab, simply go to [www.paypal.com](http://www.paypal.com) to set up an account. Then at this screen, log into PayPal.

Step 10- paying online: whether paying directly with debit or credit card or paying with PayPal, you will see a new screen to enter your payment information, and then a confirmation screen.

Step 9- paying by check: Please make your check payable to Denton County Paralegal Association in the amount of \$35.00 and mail to P.O. Box 2641, Denton, TX 76202. If payment is not received 7 days from the date of the online renewal, the member will be contacted by the membership committee, and then if payment is not received within 10 days, the member's renewal will be canceled.

Members whose firms pay for several memberships by check should complete their renewal online and verify that their office will be mailing a check for all dues payments.

Members whose employers issue payment after a waiting period (Denton County employees, for example) should complete their renewal online and submit the proper request for payment to their employer. The long-standing relationship between DCPA and Denton County allows us to wait for your payment.

If your payment will not be received by DCPA within 7 days from your renewal AND you are not a Denton County employee, please email Sunnie Palmer at [sunnie@zellmerlaw.com](mailto:sunnie@zellmerlaw.com) to provide more details.

When you log into the website, you will continue to see a balance due until your check has been received and payment has been credited to your membership.
